### Introduction

#### The Amelia Earhart Memorial Scholarship Fund

Established in 1940 to help deserving members to further accomplishments, today the Fund provides:

- **Amelia Earhart Memorial Scholarships** for licensed pilot members to advance in training and education in aviation and aerospace, including scholarships to complete additional pilot certificates and ratings, jet type ratings, college degrees, and technical training.
- **Research Scholar Grants** to add to the world's knowledge of women in aviation and aerospace.
- **New Pilot Awards** of up to \$1500 towards completion of any primary pilot certificate, such as recreational pilot, sport pilot, private pilot or non-US equivalent.
- **Maule Tailwheel Training Award** for back-to-basics conventional tailwheel aircraft training, donated by the Maule Aircraft family.

#### The Amelia Earhart Memorial Scholarships

Members, including current or past scholarship winners, may apply for any scholarship or award for which they are eligible, and members may be awarded scholarships in consecutive years. However, the Fund is designed to extend opportunities to as many members as possible, and is not intended to provide one individual member's training from start to finish.

Select the application form for the scholarship most appropriate to your circumstances and goal.

- **Flight Training Scholarship:** Fully paid scholarship for a licensed pilot to complete an additional pilot certificate or rating or pilot training course. Examples: Instrument rating, multi-engine rating, flight instructor certificate, airline transport pilot certificate, KingAir qualification training. Note: Excludes jet type rating. Requirements: Must be a current pilot with the appropriate medical certificate, and must be approaching the flight time requirement for the rating or certificate, if any.
- **Jet Type Rating Scholarship:** Fully paid scholarship to complete type rating certification in any jet aircraft. Examples: Cessna Citation, Boeing 737. Requirements: Must be a current Airline Transport Pilot with a First Class medical certificate, or non-U.S. equivalent, and at least 100 hours multi-engine flight time or combined multi-engine and turbine time.
- **Academic Scholarship:** Up to \$5000 scholarship towards college degree in aviation or aerospace. Students may re-apply for continuing support through graduation. Examples: Associates, Bachelors, Masters, or Doctorate degree in fields such as aerospace engineering, aviation technology, aviation business management, air traffic management, or professional pilot. Note: Flight training may be included if integral to curriculum. Requirements: Must be currently enrolled. Associates or Bachelors degree students must have cumulative grade point average (GPA) of 3.0 or better on a 4.0 scale, or equivalent.
- **Technical Training Scholarship:** Fully paid scholarship to complete an aviation or aerospace technical training or certification course. Examples: Airframe and/or Powerplant Mechanic certificate, Dispatcher certificate, Air Traffic Control training program, FAA / NTSB / manufacturer's safety training, manufacturer's specialized training or certification course. Note: Excludes any flight training and any technical training that is part of a college degree program – use those application forms instead.

#### ***Suggestions for strengthening your AE Flight Training Scholarship application***

- ✓ *Be an active, participating Ninety-Nines member.*
- ✓ *Strive to find low-cost flight training options.*
- ✓ *Begin flight training and complete written tests for certificate/rating sought.*
- ✓ *If short on flight time, have a plan to build time by February 1, or apply for the certificate/rating for which currently eligible. Do not add supplemental time-building flight hours to application*



## 2008 Amelia Earhart Memorial Scholarship Application Flight Training Scholarship

### APPLICANT ELIGIBILITY REQUIREMENTS

1. **MEMBERSHIP:** Applicant must be a Member of The Ninety-Nines, Inc., and been so continuously since December 1, 2006. *NOTE: Length of membership may include time as Future Woman Pilot Member.*
2. **GOAL:** Applicant must have a specific goal for advancement in aviation or aerospace. This goal may be to qualify for or to advance in an aviation-related profession or charitable cause.
3. **FINANCIAL NEED:** Applicant must demonstrate a need for financial assistance to progress toward her goal.
4. **FLIGHT CURRENCY:** At time of application, applicant must be current and qualified as pilot, i.e., current flight review, competency or proficiency check, or equivalent. *NOTE: Landing / instrument currency not required.*
5. **MEDICAL CERTIFICATE:** At time of application, applicant must possess a current, valid medical certificate required for the certificate/rating sought.  
*Example:* Applicant seeking the FAA Airline Transport Pilot certificate must have a current, valid First Class medical certificate at time of application.
6. **ONE PILOT TRAINING COURSE:** Applicant may request only one (1) pilot training course or certificate or rating.  
*Example 1:* Application for “FAA Multi-Engine Instrument rating” by an applicant already holding an instrument rating. Request is for an add-on multi-engine rating with instrument privileges – allowed.  
*Example 2:* Application for “Commercial-Instrument” by an applicant with neither rating – disqualified, *unless* training is in progress for one of the ratings (see Training in Progress, below).
7. **TRAINING IN PROGRESS:** Application may be made for a certificate/rating without holding a pilot certificate required for the new rating, provided training for that required certificate is in progress and expected to be completed before February 1.  
*Example:* With application for “Flight Instructor certificate,” applicant must either already possess the commercial pilot certificate or be in training for it with expected completion by February 1.  
*NOTE: If not provided in original application, applicant must provide proof of completion and eligibility so the designated AEMSF Trustee receives it by February 1. Failure to do so is cause for disqualification.*
8. **FLIGHT TIME:** Applicant must have sufficient flight time experience so that she will, upon completion of training requested in this scholarship application, meet or exceed minimum flight time requirements for the certificate/rating sought. Applicant may build flight time up to February 1 to meet this requirement.  
*NOTE: If not provided in original application, applicant must provide proof of flight time eligibility so the designated AEMSF Trustee receives it by February 1. Failure to do so is cause for disqualification.*
9. **APPLICATION:** The AE Scholarship application is the mechanism by which the applicant states her scholarship request, including course or training sought and monetary amount requested, and explains how this will help her to advance in aviation or aerospace. The applicant is responsible for ensuring that the application is complete and true in every respect – omission of required information or providing fraudulent information is grounds for disqualification and withdrawal of scholarship.

**No Applicant Eligibility Requirements or deadlines may be waived.**

**Disqualification will result from not meeting eligibility requirements or following procedures.**

**INCOMPLETE, LATE, or FRAUDULENT applications will be DISQUALIFIED.**

## APPLICANT INSTRUCTIONS

1. The AE Flight Training Scholarship covers the entire cost for a licensed pilot to complete one (1) additional pilot training course or additional pilot certificate or pilot rating. Examples: Instrument rating, multi-engine rating, flight instructor certificate, airline transport pilot certificate, or KingAir qualification training.  
NOTE 1: If requesting a jet type rating, use only the Jet Type Rating application.  
NOTE 2: If you are currently enrolled in a college degree program that includes flight training in the curriculum, either this Flight Training application or the Academic Scholarship application may be used as appropriate.
2. Select the scholarship appropriate to your circumstances and goal and submit one (1) AE Scholarship or Award application. Application must be submitted on 8½ x 11 paper and be neat and legible in English. It may be completed by computer, typewriter, or by hand, but all signatures must be in ink pen – electronic or typed signatures not allowed. Indicate “N/A” for “not applicable.” Use more space or attach extra page to relevant Part, if needed.
3. Verify and establish positive contact with your Section AE Scholarship Chairman, using the online directory. If none, it is your Section Governor. (Members-at-Large: it is the International President.) **Chapter Members**: Verify and establish positive contact with your Chapter AE Scholarship Chairman. If none, it is your Chapter Chairman. **Verify the submission deadline for your chapter.**
4. Chapter Members: It is the Applicant’s responsibility to request 99s Recommendation from her chapter. Submit completed application **by the deadline specified by your chapter**. The complete application package to be submitted to your chapter consists of the Application Parts I-IX including documentation (the 99s Certification and Recommendation will be blank). Provide Cover Sheet and one copy of Applicant Eligibility Requirements, Applicant Instructions, and AE Scholarship Chairman Instructions & Checklist. If you are recommended by your chapter, obtain original application with completed 99s Certification and Recommendation for submission to Section.
5. ALL Applicants: You are responsible for submitting complete application package to your Section AE Scholarship Chairman, or if none, to your Section Governor. (Members-at-Large: Submit to International President.) Submit original Application Parts I-IX including documentation – for Chapter Members, the 99s Certification and Recommendation must be completed. Submit one original, keep one copy. **Submit it so that she will receive it by the deadline of DECEMBER 1, 2007.**
6. Applicant is responsible for ensuring that application package is complete in every respect. Staple or clip pages – do not use any type of binder or cover. Make a copy of your complete application and retain for your records.
7. **MANDATORY**: If required for eligibility, applicant MUST provide the following documentation to the designated AEMSF Trustee **so that she will receive it by the deadline of FEBRUARY 1, 2008**.
  - ✓ Proof of completion of any certificate or rating in progress as per Applicant Eligibility Requirements.
  - ✓ Proof of additional hours to meet minimum flight time as per Applicant Eligibility Requirements.
  - ✓ Status of any scholarships or grants pending at time of initial application.
  - ✓ Any missing information or documentation, or any other change that affects eligibility or application.
8. Applicant is responsible for following instructions, meeting all deadlines, and tracking the progress of her application through the review and selection process. Use Applicant Checklist and follow up at every step.
9. ALL SHIPMENTS: Submit one original, keep one copy. Send in a single, trackable shipment. Retain shipment tracking number and receipt. United Parcel Service is our preferred shipping provider.
10. Winners will be notified by MAY 1, 2008 and must complete training by JUNE 30, 2009.
