MESSAGE FROM THE SECRETARY

Through the thoughtfulness of our President, Belle Hetzel, the national officers of the Ninety-Nines have been given an opportunity to address the membership in this column. Perhaps I can be of most service here by (1) outlining the general manner in which your business is handled in, or through, the Secretaryship and (2) suggesting how you can make most effective use of this machinery.

As indicated under Article VI, Section 3 of our Constitution, the Secretary is required to keep an accurate account of the transactions of the national meetings; to write official communications; file papers pertaining to the organization; draw up prescribed notices, such as those relating to dues; and perform sundry other duties.

Much of the routine office work in connection with these tasks is performed by the National Aeronautic Association in Washington, D. C., under an agreement which is subject to an annual renewal vote. It is this office which keeps the full records of each member, and upon direction from the officers of the Ninety-Nines prints and addresses notices, ballots, etc. and edits and distributes the News Letter.

This division of labor determines how one should transact ordinary items of business. It is to our headquarters office in Washington, for instance, that chairmen and other local officers should write for membership blanks and other routine forms, stationery, pins, etc. Whenever you move, be sure to drop them a postcard, giving your new location, for they mail the notices, forms, and the News Letter. Do not neglect to do this, since the post office cannot forward such printed matter. In giving your name, use the form Mrs. Ruth Featherstone Jones, or Ruth F. Jones (Mrs. John R.) instead of Mrs. J. R. Jones, to simplify the task of identifying you.

When it comes to questions of procedure, one should remember that the Washington office is ordinarily not equipped to handle them, not being manned by experienced Ninety-Nines, closely familiar with the traditions and rules of the organization. Such matters can often be cleared up, however, within the chapters themselves, merely by having someone keep and refer to a complete current file of official communications and the News Letter, wherein appear the Constitution, By-laws, an annual list of members and chapter and section officers and other material. Chapters with a rules committee or a parliamentarian might very well use them to keep the chapter and membership notified of coming events, such as nominations, the naming and instructing of delegates, and business to be transacted at the national meeting. Such specialization locally should avoid considerable confusion and last minute rushes. In any case, issues that cannot be readily handled within the chapters should be referred to the national officers. As one of these, I shall be most happy to do what I can to help.

In closing, I wish to say that the Secretaryship is not an unduly arduous task; next year's holder should find ample compensation for her labors in the opportunity to work so closely with a truly grand group of women.
